# **Foundation Trust Announces 2023 Fall Grants**

The Board of Directors of the Pendleton Foundation Trust announced that grants, memorial trust funds and scholarships given in 2023 will total \$219,849.50.

The board has awarded FALL GRANTS in the amount of \$72,704.00 to the following recipients:

- Pendleton Children's Center, \$10,000.00 toward Phase 1C/D for a new, safer drop off/pick up entrance, with sight lines to a new outdoor playground, and to expand office and support staff spaces.
- Capeco, \$22,000.00 for The Promise Inn emergency shelter program, to provide flooring to complete the last 11 rooms of the 34-room facility.
- Pendleton Christian School, \$25,704.00 to provide new Marmoleum sealed sheet flooring for the kitchen and cafeteria floors, which was formerly the Harris Jr. Academy, and serves K-8th grade.
- Horizon Project, Inc., \$15,000.00 toward the purchase of a large generator at the Pendleton office to enhance Emergency Preparedness for the many people they support.

## **Partnerships Increase Outreach**

The Pendleton Foundation Trust is based on partnerships - with those who donate funds, with community organizations, other foundations and funders, and with regional colleges. Eastern Oregon University's Foundation is a key partner in awarding scholarships to students from the Pendleton area nearing completion of bachelor's degrees. The University's scholarship application provides students the opportunity to complete one application - which may lead to a match with criteria established by donors - in this case with criteria established by the Pendleton Foundation Trust. The University then handles disbursement of funds.

By partnering with EOU, funds generated from investment earnings from Lee and Luella Dudek's estate gift can be directed to students in their junior or senior years, when fewer scholarships may be available.

Two seniors from Pendleton, Jillian Samp and Walker Camp received \$3,000 awards for the 2023-24 academic year. Jillian is an elementary education major currently student teaching second grade in Cove Elementary and "absolutely loving it!" She plans to continue her education by completing a master's degree next year.

Walker Camp is majoring in Health and Human Performance - Exercise Science Concentration, with plans to pursue a career coaching football at the college level. A football player for the EOU Mounties, Walker will complete an internship focusing on strength and conditioning at Montana State University this

winter. He enjoys fishing, working out, time with friends and family and the smaller size of EOU, adding, "You can't beat the view!"

# The Gift that **Keeps on Giving**

On May 10, 1775, the Second Continental Congress convened in Philadelphia and issued paper currency for the first time. On that day in 1940, Winston Churchill succeeded Neville Chamberlain as British Prime Minister. In Pendleton, Oregon, on that day in 1928, Col. James Raley was joined by other leaders in the area to give birth to the Pendleton Foundation Trust. I don't actually remember these important events firsthand, but it's all true just Google it.

The original Foundation Committee not only included Col. James Raley, but also James Akey, N.D. Swearingen, James S. Johns, James A. Fee and Mrs. E.W. McComas. These pioneers had the foresight to create a foundation:

- "To assist civic and educational undertakings whether now supported by private gifts or public taxation.
- To promote educational and scientific research.
- To improve living conditions or provide recreation or recreational grounds for all classes.
- For such other civic or public purposes as will best make for the mental, moral and physical improvement of the inhabitants of the City of

Pendleton, according to the discretion of the majority in number of a committee to be constituted as hereinafter provided and to be called and known as the Pendleton Foundation Committee."

Since then, we've been committee-ing for over 95 years and the Trust has given over \$4.7 million back to our community. This has only been possible because of many gifts, including several generous bequests from the Claude and Bertha Hanscom Trust, the Jessie Furnish Estate, the Mary Lecklider Estate, the Dan & Dorothy Bell Trust, the John S. "Jiggs" Fisk Estate, the David Horne Trust and most recently the Clelan Dudek Estate, which has funded scholarships for local students. Without these and many other sustaining gifts throughout the years, it wouldn't be possible for the Foundation to have such a positive impact on the quality of life in Pendleton. This is a story – and a history – of success. The success of a community gathering around a cause and supporting the vision of the Pendleton Foundation Trust founders. As Winston Churchill said (you know, the same guy who took office on the same day twelve years after our Foundation was formed? Yeah, that guy...), "Success is not final, failure is not fatal. It is the courage to continue that counts." So, to make it count, we must continue courageously and that's where you come in. Through your donations, you can join us in the mission of the Pendleton Foundation Trust and help to continue the vision that our first Trustees shared with each other and the community back on that special May 10th of 1928.
